Managing Committee shall not close down the school or an existing class during the academic session without the prior approval of the appropriate authority.

The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.

Recognition so granted shall be reviewed after every 10 years. 0

No financial assistance shall be granted by the Department to the school.

School premises shall not be used for commercial purpose and anti-National activities.

- 12. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
- 13 The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./ Department as required.
- 14. In addition to above the Managing Committee shall abide by the provisions of Harvana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
